DECLARATION STATEMENT RELATED TO ICASA NOTICE 238 OF 2020 FOR TEMPORARY ALLOCATION OF HIGH DEMAND SPECTRUM (HDS) AND PROCESSES RELATED TO THE LICENSING OF THE WOAN

MZANSIWOAN (PBICT, YEA, SABISPA) recognises and notes the ICASA Notice 238 of 2020 issued as an emergency measure as part of our country's fight against the treacherous COVID-19 pandemic which represents the greatest risk to the health and economy of South Africa.

"Regulators should have the capability to conduct appropriate analysis of the economic and societal impact of spectrum decisions, in order to give priority to spectrum uses that deliver the areatest benefit to the society and its consumers.

The release of spectrum should allow an equal opportunity for all to compete for spectrum, under rules that foster competition and innovation".

Our collective organisations wish to express our full support of all government intervention strategies which aim to safeguard and ensure the health and safety of the population of South Africa. Additionally, we fully support the need for our economy to remain functional (operational) as much as possible despite the challenges presented by COVID-19. Most importantly the need for our people to efficiently, conveniently access information and tools related to the prevention of COVID-19 through digitally (e-Health) means as well as the need for our children to continue their studies (e-Education) during the current critical lockdown period.

MzansiWOAN wishes to put it to public record that our non-profit organisations support the Minister and ICASA decision to open applications and allocate High Demand Spectrum (HDS) to industry on a temporary basis – for a period not exceeding 3 months after the termination or expiry of the National State of Disaster as per Notice 238.

We also recognise, note and support the comments attributed to ICASA Acting Chairperson as expressed in the article published at https://techfinancials.co.za/2020/04/06/sas-telcos-to-have-temporary-access-to-high-demand-broadband-spectrum/

"It is of critical importance to note that the emergency release of this spectrum does not, in any way whatsoever, negate the processes that are currently underway for permanent assignment of spectrum through an auction, the process which the Authority had committed to finalise by the end of 2020; as well as the assignment of spectrum to be set aside for the Wireless Open Access Network (WOAN) due for completion next year.

We intend to take the necessary care in this regard; and to ensure that there are no irreversible anti-competitive effects for the market. In addition, we really urge licensees to work with us for the benefit of all South Africans in a collaborative effort so that the emergency release of the spectrum can make a meaningful contribution to curb the spread and flatten the curve of the COVID-19 pandemic", says ICASA Acting Chairperson, Dr. Keabetswe Modimoeng.

MzansiWOAN (PBICT, SABISPA, YEA) as an interested party in the licensing of the WOAN and allocation of HDS to industry SERVES this DECLARATION OF NOTICE to; ICASA, the Minister of Communications and Digital Technologies, the South African Government at large, TO STATE that we will be monitoring all activities related to allocation of HDS on a temporary basis very closely from this date forth. We further declare that at a future date our collective may come to both ICASA and the Ministry to request answers on all matters documented in this letter.

MzansiWOAN refers and reminds ICASA and the Minister about further declarations made in our response (click here) to ICASA NOTICE: GOVERNMENT GAZETTE NOTICE 597 OF 2019 (1 NOVEMBER 2019): ELECTRONIC COMMUNICATIONS ACT 2005, (ACT NO 36 OF 2005),NOTICE ON THE LICENSING PROCESS FOR INTERNATIONAL MOBILE TELECOMMUNICATIONS (IMT) SPECTRUM, INVITING COMMENTS IN RESPECT OF PROVISIONING OF MOBILE BROADBAND WIRELESS OPEN ACCESS SERVICES FOR URBAN AND RURAL AREAS USING COMPLIMENTARY BANDS, IMT700, IMT800, IMT2300, IMT2600 AND IMT3500.

In protection of the OBJECTIVES of ICASA NOTICE 597 of 2019, we wish to make the special requests to ICASA, and the MINISTER related to The ICT COVID-19 National Disaster Regulations and Temporary Allocation of HDS to industry;

- 1. Full Transparency must be exercised during this time, around allocation and usage of temporary HDS
 - a. All HDS applications and approvals must become public record and published on ICASA website as soon as possible or must be shared with MzansiWOAN and other interested parties.
 - b. Temporary HDS proposed usage information MUST be public record and disclosure
 - i. Basic details Who, Where, When, Why, How must be publicized in the national interest and requested transparency.

- 2. **Audit Trail** In the interest of fair competition and future interests of smaller ISP's, MVNO's and WOAN we request that ICASA keeps a full audit trail of correspondence related to applications, email chains and approval of all activities related to allocation of temporary HDS.
- 3. ICASA, Minister, Presidency, Parliament, Competition Commission, Information Regulator as well as the Public must **reserve the right to request financial reports from industry** to check whether temporary HDS was used for financial gain or not during COVID-19 crisis period.
- 4. In principle we believe that **Temporary HDS** must be allocated and used on a **Non-Profit Basis** by all applicants, as gratitude service to South Africa and its People.

CHAPTER 10 of the Constitution of South Africa on Public Administration states basic values and principles governing public administration as follows:

195. (1) Public administration must be governed by the democratic values and principles enshrined in the Constitution, including the following principles:

- (a) A high standard of professional ethics must be promoted and maintained.
- (b) Efficient, economic and effective use of resources must be promoted.
- (f) Public administration must be accountable.
- (g) Transparency must be fostered by providing the public with timely, accessible and accurate information

We appreciate your consideration of our requests and also express that MzansiWOAN reserves constitutional rights in line with The Promotion of Access to Information Act 2 of 2000 (PAIA) legislation in the Republic of South Africa allowing access to any information held by the State, and any information held by private bodies that is required for the exercise and protection of any rights.

In conclusion, we declare our intension to safeguard and serve as custodians of the interest of SMME's, Black Business and smaller Telecommunications players as well as to serve as an instrument to prevent an irreversible monumental Spectrum Heist in the name of COVID-19 in South Africa.

Moreover, this period highlights the need for ICASA to accelerate the licensing and formation of the WOAN as well as speeding up allocation of HDS to the WOAN which could have been ideally used during this crisis period on a Non-Profit Basis for National Interest.

This period provides us with lessons and illustrates why the WOAN is a potentially important National Interest Institution and sets a good blueprint why all the power to solve national problems (crisis) should not reside in the hands of private entities who run oligopolies in RSA Telecommunications industry.
